Motion: Council President Matt McCowan moved to approve the Consent Agenda and bills to be paid as presented. Councilor Alan Cadinha seconded. Motion approved by unanimous vote.

#### **Unfinished Business**

Anonymous Nuisance Complaint on Conklin - Next Steps

Follow up was provided on the anonymous nuisance complaint on Conklin noting the owners reported the trailer is their trash trailer. It was noted by Dave Johnson that during his investigation no smell could be detected from the roadside, and the pictures that he took and shared with the mayor and council members show no garbage strewn about. The potential violations per the city's Nuisance Ordinance were noted to be attraction of vermin and stench. However, the evidence that has been gathered by the city shows no proof of these violations; therefore, the city cannot act on this complaint.

#### **New Business**

SB2 Economic Opportunity Analysis – Scott Hartell, Union County Planning Director Scott Hartell, Union County Planning Director, joined the meeting remotely. He provided a verbal report noting that he is working on a SB2 grant that was awarded to the Union County Planning Department. This bill effectively allows Eastern Oregon counties to rezone property to an employment base and applies to industrial and/or commercial zoning. The grant requires him to reach out to all 8 incorporated jurisdictions in Union County and go over the Gold Mine section of the city's comprehensive land use plan. Discussion ensued and Scott noted what he needs to find out is does the city want to grow. He further noted the City of Cove has not updated zoning since 1984. As such, it would be beneficial for the city to update its comprehensive land use plan and zoning ordinance since those documents haven't been visited since 1984. Ultimately, it was determined most community members seem to like Cove just the way it is, which is also the consensus of the Council.

Scott Hartell, Union County Planning Director, left the meeting at 7:27 pm.

#### City Hall Remodel Bid Review and Award

Dave Johnson reported the city did not receive any bids for the city hall remodel. It was noted the contractors that were contacted to bid were given three weeks to respond. Discussion ensued and it was noted that is not enough time. Dave agreed to reach out to the contractors the bid was sent to and notify them they will have more time to prepare a bid.

 She has been working on budget with Donna Lewis. However, Donna needs an increase in hours because she is up to 57 hours. Discussion ensued and it was agreed to approve 40 more hours to Donna's contract. Motion: Councilor Alan Cadinha moved to add 40 hours to Donna Lewis' contract. Discussion ensued and it was determined to amend the motion to add 60 hours to her contract. Councilor Jordan Hackwith seconded. Motion approved by unanimous vote.

He will reach back out to ODOT regarding extending the 25-mph speed zone.
